ETHICS & BOUNDARY ISSUES, DOMESTIC VIOLENCE, AND MEDICAL ERRORS: ESSENTIALS FOR CHAPTER 491 LICENSEES

This seven-hour course is designed to meet the licensure renewal requirements for clinical social workers, marriage and family therapists, and mental health counselors. Participants will meet Florida's mandate for continuing education in the areas of professional ethics and boundary issues. Content specific to domestic violence, including evidence-based techniques to assess and treat battered women who demonstrate Battered Woman Syndrome and other clinical disorders will be discussed. The medical errors portion of the course will cover prevention, including a study of root-cause analysis, error reduction and prevention, and patient safety.

Ethics and Boundary Issues: This session is designed to fulfill the ethic education requirements for licensure renewal in Florida. With emphasis on role plays and case studies, participants will review ethical principles in an effort to identiy ethical dilemmas and how to solve them. In particular, discussion will focus on moral principles and the ethical decision-making process; the counselor as a person and as a professional; stress, impairment, and vitality; values and the helping relationship; multicultural perspectives in dealing with ethical issues; confidentiality, privacy, and the exceptions to confidentiality; multiple and dual relationships; boundary issues; and sexual relationships and criminal behavior. HIPAA, FERPA, and Florida's licensure Chapters 456 and 491, and Florida Administrative Rule Title 64B4 will also be addressed.

Domestic Violence: This session will cover content specified in Florida Statutes for continuing education, as well as updated research and techniques in working with battered women who demonstrate Battered Women Syndrome, Post Traumatic Stress Disorder, Affective Disoders, and other clinical syndromes. New psycho-pharmacological interventions and standardized assessment instruments to guide treatment objectives will also be discussed. This workshop is designed to meet the licensure renewal requirements for all mental health professionals.

Medical Errors: This session will enable participants to respond to issues involving medical error reduction in the practice of behavioral health care. Through presentation and discussion of the concepts of root-cause analysis, error reduction and prevention, and reporting standards, participants will gain additional skills that will enhance client safety and well-being.

ABOUT THE PRESENTERS

Mercedes ter Maat, Ph.D., LPC, ATR-BC is a professor in the Department of Counseling at Nova Southeastern University's College of Psychology in Ft. Lauderdale. Prior to joining NSU she was the director of the school counseling graduate program at the George Washington University, Alexandria, VA campus and an assistant professor at Virginia Tech. She has over 30 years of combined working experience as a counselor educator, mental health counselor, school counselor, and art therapist. Dr. ter Maat participates in local, state, national, and international leadership undertakings for the fields of mental health counseling, school counseling, and art therapy and frequently presents on topics related to multicultural counseling, ethics, motivational interviewing, and the use of art in counseling and therapy. She actively participates in humanitarian work, most recently in Peru, Argentina, Swaziland, and Lebanon, and her research interests are in enhancing the quality of life of immigrant, minority families in crisis by identifying risk and promoting protective factors through school- and community-based interventions. She is a past-president of the American Art Therapy Association and the current president of the European Branch of the American Counseling Association. Dr. ter Maat is a licensed professional counselor and a board-certified/registered art therapist.

Lenore Walker, Ed.D., ABPP is professor emeritus at Nova Southeastern University's College of Psychology. She earned her doctorate degree from Rutgers, The State University of New Jersey in 1972, and earned her post-doctoral M.S. in psychopharmacology from NSU in June 2004. Walker has written 14 books and over 50 book chapters and articles in the area of domestic violence, child abuse, and women's issues in therapy since her first book, *The Battered Woman*, was published in 1979. She is director of the Domestic Violence Institute which has 13 affiliate centers around the world providing education and training, research, and public policy initiatives. She was chair of the APA Presidential Task Force on Violence and the Family, and continues as an advisor to the violence prevention efforts. She currently has a President's Faculty Research and Development Grant from NSU to update the Battered Woman Syndrome Questionnaire.

David Shapiro, Ph.D. is a professor of psychology at Nova Southeastern University, where he teaches courses in introductory and advanced ethics, forensic assessment, criminal law, and projective techniques. He has served on the APA Ethics Committee, chaired the Ethics Committees of the Maryland Psychological Association and the American Board of Professional Psychology, and is currently ethics chair for the Broward chapter of the Florida Psychological Association.

- Identify five moral principles and how these are taken into consideration when solving ethical dilemmas.
- Define privacy and confidentiality, and exceptions to confidentiality related to HIPAA, FERPA, and Florida Statue Laws and Regulations as applied to the practice of mental health counseling.
- Recognize boundary issues and dual relationships, and apply the steps in the ethical decisionmaking process to solve ethical and legal issues.
- Identify the numbers of victims and perpetrators of domestic violence likely to be seen in practice
- Utilize screening procedures for determining victims and perpetrators of domestic violence
- Identify local resources for victims of domestic violence
- Understand the biopsychosocial model of Post Traumatic Stress Syndrome and Battered Woman Syndrome
- Identify and assess the psychlogical impact of domestic violence
- Discuss various interventions with therapy and psychopharmacology
- Describe ways to protect victims of domestic violence in forensic cases
- Explain the scope and impact of medical errors
- Define terminology associated with medical error reduction
- Demonstrate understanding of root cause analysis related to error in behavioral health care
- Identify specific safeguards to reduce error potential across a variety of behavioral health care settings
- Demonstrate understanding of reporting and documentation responsibilities related to the commission of medical errors
