Many psychologists and therapists are observing a notable increase in cases where gender identity is the presenting or underlying concern. Clients dealing with gender often contend with other psychological challenges such as anxiety, depression, and self-harm ideation, often resulting from family denial or rejection. Even if family members are supportive, clients can find themselves in unsafe school or work environments with limited support systems. This session will review the current state of knowledge on transgender and gender nonbinary clients. Best practices in clinical care as well as case study reviews will be shared. A guest parent and/or young adult speaker who has received psychotherapy in the past will share their personal experiences and engage in Q&A with participants. The importance of linking clients and their families to peer support and educational services will also be covered. Vital contacts and resources across South Florida will be shared.

ABOUT THE PRESENTERS

Shelley Slapion-Foote, Ph.D. has been a licensed psychologist in the State of Florida since 1986. She is a product of the Miami-Dade County Public Schools (Miami Norland High School), Barry University (then Barry College), and the University of Miami where she earned her master's degree and Ph.D. degrees. In addition to her master's degree and her doctorate, she met and married her husband, Dr. Franklin Foote, also a psychologist and supporter of the YES Shelley was also instrumental in establishing psychology as a major at Barry Institute. University, and was one of three individuals to graduate with a major in psychology in 1975. Barry's psychology program has expanded to also have two master's degrees in psychology. She also established the American Psychological Association's National Honor Society for Psychology, Psi Chi, while still a student at Barry. After graduating from the University of Miami in 1984, she has continued to be very active in community involvement through the Florida Psychological Association (a division of the American Association). She is currently President of the Miami-Dade-Monroe Chapter of the Florida Psychological Association (FPA), and was named Psychologist of the Year in 2019 by FPA for which she is very proud. She has cochaired the Southeastern Regional Conference for FPA in 2016, 2018, and 2020. Approximately five years ago, Dr. Shelley attended a series of workshops at YES Institute and knew she had found a new home and hasn't left since. She has served on the Board of Directors, is a consultant to YES Institute, as well as a donor. One of her goals is to provide services for those in the YES Institute community and the community at large. Her other mission is to make YES Institute NOT one of the best kept secrets in the country.

Joseph Zolobczuk, M.S.Ed. has served on staff with YES Institute for 25 years. As the Executive Director of YES Institute, Joseph supports and guides an amazing team who lead continuing education courses for teachers, mental health therapists and medical professionals across South Florida - and national communities via Zoom - working to reduce health disparities of youth and families impacted by gender stereotypes and anti-gay social stigmas. He also serves communities throughout the United States through SAMHSA's TA Network, providing cultural and linguistic consultation to systems of care with youth and adult mental health and substance abuse prevention populations. Joseph has co-authored two public health studies, the first anti-gay and gender-related school bullying study in Florida, and a study comparing workplace harassment and inclusion training levels among helping professionals. Joseph also co-produced and directed the LGBTQ Diversity & Inclusion video training for the Greater Miami Convention & Visitors Bureau Miami Begins with Me hospitality online training certification program. He is invited as a guest speaker to hospitals, mental health networks, and other community agencies locally and across the US to reduce disparities and improve health outcomes for youth and adults who represent diverse experiences of gender and orientation. He completed his Master's in Education from the University of Miami's School of Education & Human Development in May 2012, and was awarded the Student Silver Medallion award for humanitarian service from the Miami Coalition of Christians & Jews (MCCJ) that same year.
