ABOUT THE PRESENTERS

Dr. Tara Jungersen, Ph.D., LMHC, CCMHC, NCC is a Professor in the Clinical Mental Health Counseling program in the Department of Counseling at Nova Southeastern University's College of Psychology. She completed her Ph.D. in Counselor Education and Supervision at the University of Tennessee, and her M.Ed. in Community Counseling at the University of Virginia. Prior to joining the faculty at NSU in 2009, she worked extensively in community behavioral health facilities providing crisis intervention, mental health, trauma, substance abuse, and domestic violence services across several levels of care. Since that time, she has trained and supervised clinical mental health counseling students and chaired the department through two, first-time program accreditations. Her current research focuses on intimate partner violence, trauma, and treatment access for underserved populations. She is currently co-authoring the third edition of the Survivor Therapy Empowerment *Program*, a trauma-informed treatment program for survivors of gender-based trauma and serves on the board of the Broward Domestic Violence Council. She is currently the Managing Editor of *Trauma* Counseling and Resilience, the journal of the International Association of Resilience and Trauma Counseling (a division of the American Counseling Association). She is a Florida Licensed Mental Health Counselor, a Florida Qualified Supervisor for the Mental Health and Marriage and Family professions, a Certified Clinical Mental Health Counselor, and a National Certified Counselor.

Shannon Karl, Ph.D., LMHC, NCC, CCMHC, ACS is a Professor with the College of Psychology at Nova Southeastern University. She received her doctorate from the University of Central Florida in 2004. She has extensive clinical mental health experience and is a Licensed Mental Health Counselor and Supervisor in the State of Florida as well as a National Certified Counselor and a Clinically Certified Mental Health Counselor. Dr. Karl has published in the areas of interpersonal violence, counseling student performance, spirituality, addictions, trauma, and the DSM-5. She is the Past-President of the Association for Spiritual, Ethical, and Religious Values in Counseling (ASERVIC) and is a co-author of the DSM-5 Learning Companion for Counselors (2nd edition scheduled for publication early 2023). Dr. Karl has also conducted over a hundred presentations at regional, national, and international conferences
