PRACTICUM AND INTERNSHIP

The **Clinical Experience*** portion of the program will consist of three continuous semesters, including one semester of practicum and two semesters of internship completed at an approved agency or community placement. Students must follow all requirements and policies and procedures of the university and host agency.

Practicum: requires a minimum of 150 hours with 40 hours of direct client contact (approximately 10 hours per week each term; students will fulfill hours as required by their agency placement).

Internship: (minimum two continuous semesters consisting of 300 hours each with 120 hours per semester of direct client contact (approximately 20 hours per week each term or as specified by placement).

*Students wishing to pursue licensure in Florida are required by the state of Florida to complete 1000 hours before beginning post-master's level supervision. These students may increase practicum and/or internship hours, add additional semesters of clinical experience, or complete remaining hours during employment or privately contracted supervision (if permitted). Students seeking licensure in other states should check that state's licensure requirements that may vary.

**Students entering practicum/internship training in any program may find it necessary to make special arrangements with their employer, including taking a leave of absence, to fulfill this requirement. Students will need to arrange their schedules to complete this requirement.*

Students will be required to meet all prerequisite requirements prior to beginning their practicum. Further information can be obtained at the following:
