The practicum at the Clinic for Research and Treatment (CRT) is an innovative center that provides training, development, and therapeutic initiatives designed to enhance the quality of life for service members by equipping them with essential life and self-regulation skills. Our principal program is a pioneering approach to treatment in collaboration with The Veterans Trust by blending elements of stress inoculation treatment, simulated racing with psychological skills training to help participants improve their mental and physical health, often related to trauma. Currently, we provide a host of services for veterans, active duty, and first responders, which include: • Psychological Skills Training • Continuing education for first responders • Biofeedback and Neurofeedback • Stress Inoculation Training • Simulation-based training • Sleep Therapy (Potential for CCE) We are actively working on developing additional treatment (which would allow for a CCE case) and therapeutic approaches, including: • STAIR Narrative Therapy • Ketamine Therapy with wrap-around psychoeducational treatment • Diet and Nutrition Students who work within the practicum will get experience with assessment, biofeedback and neurofeedback, research, and therapy. We also conduct forensic evaluations for Childnet and Immigration Attorneys.

ATC provides state of the art diagnosis, assessment, and treatment for adults with anxiety and other comorbid psychiatric and/or medical conditions. ATC specializes in the treatment of panic, social anxiety, GAD, specific phobias, and OCD. Students may also treat comorbid depressive, personality, trauma/PTSD, sleep, and alcohol/substance use disorders. Students will be trained in the most current manualized, evidence-based treatments which provide a nice structure for new clinicians. Students have the opportunity to learn CBT, ERP, ACT, DBT, PE and CPT. Students will also be trained in several evidence-based diagnostic/assessment measures (SCID, ADIS, WAIS, MoCA, etc.). Students will learn how to administer, score, interpret measures, and write integrated reports. Students will learn effective documentation/writing, treatment planning, and develop strong clinical skills. CATSP OVERVIEW CATSP serves children and families who have experienced a variety of types of trauma, bereavement, bereavement, and other losses. We also provide diagnostic and clinical assessment for traumatic stress and bereavement-related disorders, including posttraumatic stress disorder (PTSD) and prolonged grief disorder. CATSP students will be engaging in evidence-based assessment and treatment of children and adolescents and their families who have experienced various adverse childhood events, with a specific emphasis on traumatic stress/PTSD and bereavement/loss/grief. **CATSP HOUR REQUIREMENTS:** **DIRECT CLINICAL CONTACT** -CATSP students will be engaging in evidence-based assessment and treatment of children and adolescents and their families who have experienced various adverse childhood events, with a specific emphasis on traumatic stress/PTSD and bereavement/loss/grief. -A first-year practicum student will complete at least 10-15 weekly hours associated with the practicum. Of these, a minimum of 4-6 hours weekly will be devoted to direct client contact hours. -CATSP students will be engaging in evidence-based assessment and treatment of children and adolescents and their families who have experienced various adverse childhood events, with a specific emphasis on traumatic stress/PTSD and bereavement/loss/grief. -A first-year practicum student will complete at least 10-15 weekly hours associated with the practicum. Of the total hours, 40% (a minimum of 6 hours) are expected to be devoted to clinical contact (assessment, intervention, or consultation). **CATSP ATTENDANCE REQUIREMENTS** -Participate in All-CATSP Didactic Training sessions (supervisors/all CATSP students) for 2 hours/month (format to be decided based on schedules). -Weekly small group (2-5 students) supervision with either Dr. Layne or Dr. Loeb: 2-3 hrs./week (day/time set by supervisor/small group members) -Weekly CATSP Coordinator/practicum student individual meetings: 1 hr./week. **CATSP CURRICULUM:** Content covered in All-CATSP Didactic Training sessions will include training in: -Emergency Response Packet (protocol and supplementary materials) - Conducting Formal Risk Assessments Mandated Reporting Laws -Child-on-Child Reporting Laws - Columbia Suicide Severity Rating Scale (C-SSRS) Training and Practice -Other Relevant Topics (as determined by the CATSP Leadership Team, comprised of both CATSP clinical supervisors and the CATSP Coordinators) -Clinical competency examination (CCE) presentations by more experienced students - Guest speakers (presenters/topics to be announced) -Formal Online Training -Required Reading Materials -Presentations in CATSP meetings (led by CATSP Coordinators) -First-year CATSP practicum students are strongly encouraged to enroll in Dr. Layne's section of Case Conceptualization in Winter Semester given that he covers a broad range of core competencies that are integral to (but not specific to) trauma-informed practice. Many of these competencies help trainees prepare for their CCE case and for internship interviews. **INTERVENTION TRAINING OBJECTIVES** -CATSP practicum trainees will be able to select and implement various evidence-based assessment measures and manualized interventions based on a variety of client factors. These factors include presenting problems, diagnostic/assessment profile, prior history, developmental level, mental abilities, diversity considerations, family structure, logistical considerations, and client motivation and informed preferences. **INTERVENTION TRAINING METHODS** CATSP trainees will

Loeb or Layne on the basis of their respective areas of professional experience and expertise. **ASSESSMENT TRAINING OBJECTIVES** -CATSP clinicians will be able to conduct a comprehensive evidence-based biopsychosocial (BPS) evaluation and record the resulting findings in a professional-quality written report in APA format. Writing guides for this work include: -The most recent edition of the APA Style Manual (for writing in APA style) -Strunk and White (currently 4th edition) (for writing clear and concise prose). -An extensive BPS Model Assessment Report has been developed by the CATSP Leadership Team over several years. This Model includes examples of written text and extensive call-out comment boxes compiled from years of prior edited BPS reports. CATSP practicum trainees are required to read through the entire Model Report, including all comments, as part of preparing to write their first report. The Model Report should also be used liberally as a reference while writing all trainee BPS reports.

ASSESSMENT TRAINING METHODS -CATSP students will complete at least four comprehensive biopsychosocial evaluations using an assessment battery consisting of carefully- and individually-chosen measures. -These measures will varyingly be used in such assessment applications as risk screening, baseline/clinical assessment, diagnosis and differential diagnosis, case conceptualization, treatment planning, ongoing surveillance and progress monitoring, and assessment of post-treatment outcomes.

SUPERVISION OBJECTIVES -Practice presenting clinical cases in clear, accurate, efficient, comprehensive, logical, and clinically actionable ways. -Gain guidance and support in refining case conceptualization, enhancing understanding of client issues, and treatment planning. -Offer constructive feedback to peers on their cases, fostering a collaborative and supportive learning environment. -Engage in collaborative problem-solving with the supervision group to address and manage complex case scenarios. -Enhance understanding of diverse therapeutic approaches and their application through group discussion and shared experiences. -Improve ability to integrate theoretical knowledge with practical application in real-world clinical settings. -Practice making professional decisions (e.g., thinking through ethical dilemmas, identifying stakeholders, selecting measures and interventions, and considering whether to terminate) using the best available evidence. -Build professional competency and confidence in clinical decision-making and professional self-care through reflective supervision practices.

SUPERVISION METHODS CATSP students will: -attend group, individual, and peer-to-peer supervision. -practice presenting case facts, including presenting problems, assessment results, and other sources of information (e.g., school records). -present their case conceptualization of their clients and treatment plans. -provide constructive feedback and suggestions to one other on their cases (e.g., measures for assessment batteries, manualized interventions, theoretical orientations, treatment protocols/manualized interventions, treatment goals, intervention skills, methods for adapting or tailoring interventions) -deliberate with one another and supervisors to brainstorm ideas for difficult case presentations, ethical dilemmas, and other problems. -present and discuss how the undergirding theory (upon which the intervention is based) guides treatment. This includes the selection of treatment goals, session objectives, and practice elements/therapeutic skills used. -critically reason through and share their treatment decisions (e.g., assessment measure selection, diagnosis/differential diagnosis, case conceptualization, treatment planning/goals, methods for engaging clients, etc.). -Come prepared to present (in large or small group supervision), discuss, and deliberate over ethical dilemmas, including quoting and citing appropriate references (e.g., APA Code of Ethics, Florida Statutes, etc.) to serve as guidelines to deliberations. -receive feedback from peers and supervisors in respectful and supportive ways so as to foster a collaborative and supportive environment.

The Nova Southeastern University (NSU) Counseling Center for Older Adults treats adults ages 55 years or older who are interested in developing more effective ways of managing the difficult situations and challenges that can occur in life. Trainees provide individual, couples, family, and group counseling as well as psychological testing services to children, adults, and seniors who otherwise could not afford private treatment. In this inpatient pediatric hospital setting, the practicum student receives experience providing therapeutic interventions on an inpatient and outpatient basis with children, adolescents, young adults, and families managing acute and chronic medical conditions. Training opportunities are within the pediatric solid organ transplant programs (heart and kidney), hematology/oncology service, hemodialysis unit, adolescent bariatric surgery program, and inpatient consultation-liaison services. The practicum experience at Lifeskills South Florida provides trainees with a structured, clinically rich opportunity to develop professional competence within a dual-diagnosis residential and partial hospitalization setting. Practicum students function as emerging clinicians-in-training and are expected to maintain professional conduct at all times, including punctuality, appropriate clinical attire, respectful communication, and consistent demonstration of integrity and accountability. Interns must follow all confidentiality policies, including strict adherence to HIPAA guidelines and the ethical codes of their governing professional organizations, and are required to immediately consult their supervisor regarding any concerns related to ethics, safety, boundaries, or client welfare. Throughout the practicum, trainees participate in a wide range of clinical responsibilities aligned with their level of training, such as observing and assisting with intakes, co-facilitating or observing group therapy sessions, engaging in clinical observations, and contributing to treatment team meetings. Under supervision, interns develop skills in case conceptualization, treatment planning, and evidence-based intervention strategies while learning to maintain appropriate therapeutic boundaries and support the milieu in a professional and therapeutic manner. Interns are responsible for completing accurate, timely, and clinically appropriate documentation in BestNotes or the designated EHR system, including progress notes, group notes, session summaries, and other required records. They are expected to communicate proactively with supervisors regarding absences, emergencies, or scheduling issues, seek clarification when uncertain about protocols or clinical decisions, and actively incorporate feedback to support continued professional growth. Before engaging in client care, trainees participate in a comprehensive orientation that includes training on facility procedures, safety protocols, confidentiality requirements, documentation standards, crisis intervention guidelines, and the interdisciplinary treatment model used at Lifeskills. Supervision is a central component of the practicum, and interns receive weekly individual supervision as well as group supervision or case conferences when available, allowing them to present cases, review documentation, and receive ongoing guidance and support from licensed clinicians. Trainees are expected to be on-site consistently during agreed-upon days and hours, typically aligning with core clinical programming times, which include morning meetings, therapeutic groups, and interdisciplinary team discussions. They are integrated into the collaborative treatment environment and learn to coordinate care with therapists, psychiatrists, nurses, case managers, and other professionals. Midpoint and final evaluations are conducted to assess progress in clinical skill development, professionalism, documentation competency, ethical adherence, communication, and overall readiness for increased clinical responsibility. As appropriate and based on competency, interns may also have opportunities to observe psychiatric evaluations, participate in psychoeducation development, assist with treatment planning, or gain exposure to multiple levels of care across residential and PHP settings. Overall, the Lifeskills practicum is designed to immerse trainees in meaningful, supervised clinical practice while fostering the development of strong professional identity, ethical practice, and competence in working with complex mental-health and substance-use presentations.

The practicum at the University of Miami's Center for Cognitive Neuroscience and Aging (CNSA) provides doctoral trainees with comprehensive, hands-on training in neuropsychological assessment within a culturally diverse, community-based research setting. Students gain experience working across multiple federally and state-funded aging research programs, including NIH/NIA R01 studies, the Florida Department of Health (FLDOH), and the Florida Alzheimer's Disease Research Center (ADRC). Trainees receive supervised instruction in clinical interviewing, standardized cognitive testing, case conceptualization, and interpretation of neuropsychological data, with a focus on early detection of Alzheimer's disease and related disorders. The Child and Adolescent Mood and Anxiety Treatment (CAMAT) program in the Department of Psychology at the University of Miami is a clinical research program dedicated to developing and testing state-of-the-art psychotherapy approaches for emotional disorders in children and adolescents. Training in evidence-based practices (The Unified Protocols for Transdiagnostic Treatment of Emotional Disorders in Children and Adolescents; Comprehensive Behavioral Intervention for Tics) will be provided. Second-year trainees are expected to maintain a caseload of 5 individual clients in addition to 1 UP-C group client. Elective practicum students are expected to maintain a caseload of 4 individual clients in addition to 1 UP-C group client. Trainees will co-facilitate UP-C parent or child group one night per week. <p>This advanced practicum is for students with experience in neuropsychological testing and who have a basic understanding of brain-behavior relationships. Students will be prioritized from the Neuropsychology track, who have taken some neuroscience and neuropsychology courses and received supervision in neuropsychological assessment. Practicum requires a 16 hour (two days per week) commitment. Students are assigned one evaluation case per week and will receive intensive supervision on their clinical work on a weekly basis. This is an in-person practicum but there are also, on occasion, telehealth virtual assessments to accommodate patients requesting remote testing due to transportation or mobility issues. Outpatient neuropsychological assessment involves an in-depth immersion in brain behavior relationships. Students will work closely with all faculty in the Division of Neuropsychology and Cognitive Neuroscience as well as Department of Neurology faculty. All students will learn a core test battery and receive additional training in supplemental testing to best address a patients' referral question. Students will gain experience in wide range of neurological disorders including traumatic brain injury, epilepsy, infectious diseases, brain tumors, toxic exposures, Alzheimer's disease and related dementias, hydrocephalus, movement disorders, multiple sclerosis, anoxic events, sleep disorders, tumors, and vascular disease. While our populations predominantly involve adults (18-90+ years), the sports neurology division provides interdisciplinary clinic experiences in assessing adolescents and young adults that have sustained sports and non-sports related concussions or traumatic brain injuries. In addition, students will have the opportunity to conduct pre- and post-surgical evaluations for epilepsy and deep brain stimulation (DBS) and participate in pre-surgical interdisciplinary epilepsy and DBS conferences, brain mapping, and WADA procedures. These interdisciplinary experiences are invaluable for the trainee to learn first hand how a clinical neuropsychological plays a vital role as part of a dedicated interdisciplinary surgical team. There are also opportunities for inpatient bed-side examinations. Supervision and division meetings are offered both in-office and on telehealth. As mentioned above, students will also be trained in cutting-edge telehealth remote assessments for patients who cannot make an in-person evaluation due to limited transportation and /or mobility capacity.

The Child and Adolescent Acute Inpatient Unit (CAAP) provides short-term care for children and adolescents, ages 6 through 17, presenting with a wide range of severe psychiatric disorders including Mood Disorders, Anxiety Disorders, Psychosis, Developmental Disorders, Disruptive Behavioral Disorders, Adjustment Disorders, Personality Disorders, etc. The patient population is diverse, though many of the patients come from highly conflictual family dynamics, lower SES family systems, and/or have been abused and/or neglected in some manner. Commitment: Between August 10, 2026 through August 9, 2027, students will be expected to complete two to three clinical rotations for the duration of the training year that are often spread across 2-3 days or half days, one to two hours of individual/group supervision per week with two to four supervisors over the course of the practicum, and attendance at a weekly didactic seminar (one hour/week; Wednesdays from 12-1pm), which average to a total of 12 hours in the clinic each week. Most clinical rotations operate during normal business hours, though some may require early evening hours. Please note that in some cases students may need to exceed 12 hours in the clinic per week based on student preferences as most rotations require either a full day or a half day of clinical work. All students must pass Level II background checks and a 10-panel drug screen which includes testing for marijuana. All students will also be required to participate in the UM Mailman Center LEND (Leadership Education in Neurodevelopmental Disabilities) program. The LEND program goals are to provide disciplinary and interdisciplinary leadership training to improve systems of care that work towards the prevention of developmental disabilities and ensure access to family-centered, culturally competent care for children with or at risk for neurodevelopmental disabilities and other chronic conditions and their families. As part of LEND, students would be required to complete the LEND 'Understanding the Family Perspective' (UFP). This 4-week course (meets Fridays from 9am-12pm) provides trainees with an opportunity to learn core LEND principles in a small-group, interprofessional setting. Guest speakers present on related topics. Trainees work with a faculty mentor to develop a mock advocacy project (but are not required to carry it out—just propose one) as a part of the UFP. Also, prior to participation in the UFP, trainees complete online modules in advocacy, family-centered care, interprofessional teams, transition, and cultural competence (takes about 2 hours to complete). The UFP repeats every 4 weeks so the students can take it at any point in the year, including summer if it is more convenient. Prerequisites: Advanced students (4th and 5th Year) with coursework in child psychopathology, child development, child assessment, and child therapy. At least one practicum with children, preferable more. Spanish/Creole/French skills desirable but not required. Reliable transportation to and from the Mailman Center, and to and from community sites (if required by rotation). Practicum Summary: The Mailman Center's comprehensive training program provides training to doctoral level psychology students from area universities and to interns and postdoctoral fellows from programs across the United States and Canada. The program is accredited by the Committee on Accreditation of the American Psychological Association. We offer experiences in psychological assessment, evidence-based treatment, pediatric consultation and liaison, child protection, assessment and secondary prevention in at-risk populations, parent counseling, in-service training, seminars, clinical and developmental research, program evaluation, community intervention, and numerous interdisciplinary and intradisciplinary activities. Trainees gain experience with a broad spectrum of problems in a diverse cultural, ethnic, and socioeconomic pediatric population. While the faculty represents a number of theoretical positions, the program leans towards a cognitivebehavioral/ systems perspective. During the application and selection process, students rank their interest in one or more of four available clinical training tracks. The program is structured to build skills in the core domains of clinical/developmental assessment, intervention, prevention, and consultation in pediatric populations within a variety of settings (e.g., outpatient therapy, medical inpatient and outpatient, schools, and other community sites). A core objective of the training program is to provide trainees with an awareness of the various roles and functions of the psychologist as an interdisciplinary team member. Practicum Student Roles and Contributions: Under the supervision of licensed clinical psychologists, trainees will conduct assessment, intervention, prevention and/or consultation with child and pediatric populations. The specific role and contributions of the trainee vary across clinical rotations and will be outlined by rotation supervisors during orientation. Supervision: Trainees will receive one to two hours of individual/group supervision from two to four supervisors over the course of practicum. Live supervision is available on many rotations. The amount, structure and approach to supervision vary according to the rotation and supervisor. Clinical Hours: Approximately 12 hours weekly from August 10, 2025 through August 10, 2026. Includes one-two hours of supervision and one hour of didactics weekly. Although many rotations build in supervision and writing time, additional time outside of clinical rotations may be required for supervision, training and preparation, and the writing of progress notes and reports. The specific clinical activities, supervision and documentation requirements vary across the rotations. This will be presented during orientation prior to the trainee's ranking of rotations. The goal of the Psycho-oncology, End-of-Life, and Bereavement Practicum at Sylvester Comprehensive Cancer Center is to provide trainees with the opportunity to gain supervised clinical experience with adult patients with a history of cancer, caregivers of patients with serious or acute illness, and bereaved family members, including parents bereaved by cancer or suicide. Practicum Description: The program is designed to provide a wide range of clinical experiences with children, adolescents, and families. The student will be responsible for providing behavioral consultation on the medical floors to children, adolescents, and their families. Consultation Liaison: As part of the Consultation Liaison service, Practicum Students serve as consultants to physicians, medical residents, child life specialists, nutritionists and nursing personnel involving patients experiencing behavioral and emotional problems associated with a medical condition. They learn rapid assessment and differential diagnosis of psychological factors affecting a wide variety of medical conditions. The focus is on children and adolescents who have acute or chronic medical problems and prevention of complications due to medical conditions in children and adolescents. Services are provided to patients on the following inpatient/outpatient units: Neurology, Diabetes/Endocrinology, Pediatric Intensive Care, and Gastroenterology, among others. The training experience focuses on the behavioral aspects of chronic illness (e.g., diabetes, asthma, Crohn's disease, etc.), adherence with treatment regimens and problems with disease management (e.g., stress management during medical procedures), and supportive interventions for children and adolescents with chronic diseases. In addition to the Consultation Liaison rotation patients, students are required to do outpatient therapy follow-ups with 3-4 patients a week, as needed. Supervision: Practicum Students can receive 1 hour of individual supervision each week* (see below) and 1 hour of clinical group supervision. Students will also participate in weekly topic specific seminars. Supplemental rotations: (needs approval by supervisor): In addition to the Consultation Liaison rotation, add-on practicum opportunities are available for: Outpatient Therapy (5-7 hours per week): Outpatient therapy is provided to children and adolescents with a wide range of academic, behavioral, and developmental concerns on individual basis. Practicum Students receive training in individual, family and group modalities and will be able to apply psychotherapeutic techniques. They acquire experience with children, adolescents and family members utilizing both long term and short-term modalities. They will be able to develop and implement therapeutic interventions for children experiencing emotional concerns, behavioral disruption and family systems dysfunction. They will also develop and implement interventions for behavioral/emotional problems associated with chronic and acute medical conditions. Children and adolescents who are presenting with or are at risk for emotional and behavioral problems are seen. Children from preschool age through adolescence and their families are seen in consultation. Emphasis is on the assessment and treatment of common behavior problems including attention deficit hyperactivity disorders, mood and anxiety disorders, oppositional defiant and conduct disorders, eating and elimination disorders, trauma and developmental spectrum disorders. Cognitive-behavioral, developmental, and family systems perspectives are emphasized in understanding psychopathology and developing intervention strategies. Practicum Students typically have 4 to 5 therapy cases per week.

- Individual Therapy -Presenting problems include anxiety, depression, aggressive behavior, autism, ADHD, as well as psychosocial factors related to medical conditions.
- Groups- Practicum Students can participate as leaders for a variety of clinical groups, such as groups for Social Skills, Anxiety, and ADHD (as available year to year).

Pediatric Health Clinics (6-8 hours per week): The Practicum Students will participate in a variety of multidisciplinary clinics and teams addressing medical conditions, such as diabetes, migraines, GI disorders, and neurodevelopmental disorders. The format on this track is a developmental process that involves observation of evaluations/interventions under direct supervision and subsequently completing the evaluations/interventions without direct supervision. Training in psychoeducational and developmental assessment is provided in the areas of clinical interview, assessment, and direct observation of the supervisor working with patients and their families. Description of the Practicum

This practicum site provides fourth-year doctoral students with advanced training in forensic evaluation within a private practice setting. Dr. Nicole Graham, a forensic psychologist and neuropsychologist, specializes in evaluations across criminal, probate, civil, administrative, and third-party referral contexts—including specialized neuropsychological evaluations for pilots and Air Traffic Controllers (ATCs) requiring FAA medical certification. Students will develop competencies in forensic interviewing, psychological and neuropsychological assessment, diagnostic formulation, court preparation, and report writing. No intervention hours are offered, aside from occasional assessment-feedback sessions. Students will typically participate in 2–4 evaluations per week, engaging in clinical interviews, psychological and neuropsychological testing, collateral interviews, and comprehensive record review. They will also assist with preparation for litigation, including reviewing opposing experts' reports, helping draft examination outlines, and observing Dr. Graham's trial strategy meetings, pretrial conferences, and courtroom testimony when appropriate. Students will have opportunities to observe court proceedings and gain exposure to the operational and business aspects of a forensic private practice. Evaluations primarily involve adults, with occasional adolescent cases, presenting with a wide range of psychiatric, cognitive, and personality disorders. Caseloads include criminal forensic evaluations (e.g., competency, insanity, mitigation), civil and probate matters, FAA neuropsychological evaluations for medical recertification, and complex cases requiring multidisciplinary considerations. Students will work with culturally diverse populations, including individuals who require interpreters (e.g., Spanish, Creole, and other languages). These evaluations take place in Dr. Graham's Fort Lauderdale office and in correctional, medical, and treatment facilities across Broward and Palm Beach Counties, with occasional work in Miami-Dade County. Many environments—such as jails, forensic hospitals, and acute care centers—can be loud, cold, hot, crowded, or malodorous, and may involve intrusive security procedures. Students must maintain professionalism, adapt easily, and work objectively with individuals who may present with complex histories, high-risk backgrounds, or challenging behaviors. This practicum requires maturity, discretion, flexible problem-solving, and the ability to think critically within a high-stakes forensic context.

The Youth Services Department is funded by Palm Beach County to provide FREE short-term, trauma-informed therapy services for youth up to age 22. The practicum is 20 hours a week at the Education & and Training Center (Ed Center), which provides family therapy, Parent-Child Interaction Therapy (PCIT; ages 2-78), individual therapy (ages 18-22 only), and parent education, and psychological evaluations. The practicum student is also required to complete at least two psychological evaluations along with completing intake assessments, risk assessments, consultation, and case management. The Ed Center also provides community presentations on mental health topics related to youth and families, such as building attachment, youth and healthy social media practices, and managing anxiety. The practicum student is required to complete a one- hour community presentation on a topic of their choice that is approved by their supervisor. The office is open Monday to Thursday 8:30am to 7:00pm. Practicum trainees are expected to be on site 20 hours a week (2 full days). During that time, they are required to attend didactic trainings every Wednesday from 9:30am to 11:30am and group supervision every Tuesday from 1pm to 3pm. Practicum trainees receive one hour of individual supervision by a licensed psychologist and one hour of individual supervision from a postdoctoral fellow. In addition, the practicum trainee should be available for two evenings each week in order to schedule therapy sessions with clients. At least one morning each week should be available for administering psychological evaluations. A required four-day orientation will take place from August 3rd to 6th from 8:30am to 4:30pm. During the first month of placement, trainees are also required to participate in a two-day introductory training on the Sanctuary Model of Trauma Informed Care.
