

# **READING DISORDERS: DIAGNOSIS, DISORDER SUBTYPES, AND INTERVENTION**

This workshop will provide participants with an overview of the current reading research with a focus on dyslexia, reading intervention /instructional practices, and the psychologist's role in supporting literacy for school aged children. Researchers agree that reading disorders have several subtypes; phonological, orthographic, mixed phonological and orthographic, comprehension, language, fluency, and global or non-specific reading disorders. Dyslexia type reading disorders are often phonological or phonological and morphological in nature. The presenters will provide detailed intervention strategies and programs for improving outcomes for these types of reading disorders. The psychologist's role in identifying reading disorder subtypes and targeted interventions will be discussed. A detailed list of references will be provided to workshop attendees.
